Any Malaysian Chinese carrying on any commercial or industrial activity within any area of the Bintulu Division, Sarawak, be it a firm, company, corporation or organization with a valid trade license, may apply to be a member of the Chamber.
2. 任何超过 50% 由马来西亚华裔组成之商号、公司或组织，均被视为马来西亚华裔。  
Any firm, company, corporation or organization which is owned or controlled by more than 50% of any Malaysian Chinese shall be deemed to be a Malaysian Chinese.
3. 本会的每一位会员应指定一位定居在砂拉越州的马来西亚华裔公民作为其商号、公司或组织之全权代表，或指定一位候补代表。而这位代表或候补将有资格投票，并被选为本会或任何理事会/委员会成员。每位会员只能选派一名代表参加会员大会。  
Every member of the Chamber may nominate one natural person and one alternate of Malaysian Chinese domiciled in the State of Sarawak as representative to represent its firm, company, corporation or organization in the Chamber and shall be eligible to vote and hold any office in the Chamber or any of its Committees of whatever descriptions.
